

## Official Ballot Presidential Preference Vote Nonpartisan Office and Referendum April 2, 2024

Notice to voters: if you are voting on Election Day, your ballot must be initialed by two (2) election inspectors. If you are voting absentee, your ballot must be initialed by the municipal clerk or deputy clerk. Your ballot may not be counted without initials (see end of ballot for initials).

Vote for an uninstructed delegation from Wisconsin to the national convention of the party you have chosen.</li> <li>3. Write in the name of another person to become the presidential candidate of the party you have chosen.</li> </ol> <p style="text-align: center;"><b>Fill in ONE oval in ONE party.</b></p>
